## RESOLUTION 2020-07

### **A RESOLUTION AMENDING THE BYLAWS OF MIDWAY CITY REGARDING PROCEDURES IN FROM OF THE PLANNING COMMISSION, AND RELATED MATTERS.**

**WHEREAS**, Utah Code Title 10, Part 8 authorizes a municipality to adopt policies, procedures and regulations to facilitate the enforcement of the municipality's laws and ordinances, to promote the efficient administration of the municipality's business, and to protect and promote the public health, safety and welfare; and

**WHEREAS**, the Midway City Council finds it in the best interests of the City and the public to recognize the adoption of policies and procedures for the City in a Policies and Procedures Manual that can be readily accessed by City officials, City employees and the general public; and

**WHEREAS**, the Midway City Council finds it in the best interest of the City and the public to amend its policies and procedures from time to time; and

**WHEREAS**, the Midway City Council desires to amend the policies regarding procedures for the Midway City Planning Commission, as set forth herin.

**NOW THEREFORE**, be it hereby **RESOLVED** by the City Council of Midway City, Utah, as follows:

Article 9 Section 5 subsections (i) and (iv) shall be amended as follows:

- (i) is hereby deleted.
- (iv) shall read "After completion of any discussion/amendment, calls for a vote of the Commission.

The subsections shall be renumbered to account for the deletion of subsection (i).

Article 12 shall be amended by adding the following language at the end of the Article:

**Recusal by a Planning Commission Member**

If a member of the Planning Commission feels strongly about a subject or issue and has the desire to appear before the City or County Council or other boards and be heard on the issue, that Planning Commission member may do so only after recusing

themselves from the Commission for that particular item. Such member must recuse themselves prior to action being taken on the subject or item at issue. Then and only then can the Planning Commission member appear and be heard in front of other boards including the City or County Council, but such member may not be heard by the Planning Commission due to their membership on the Commission and their intrinsic role on the Commission.

Section 2: This Resolution shall take effect upon publication as required by law.
