## ORDINANCE 2020-\_\_

### AN ORDINANCE MAKING ORGANIZATION AND COMMITTEE TERM LIMITS UNIFORM IN TITLE 2 AND TITLE 12 OF THE MIDWAY CITY MUNICIPAL CODE

**WHEREAS**, the City Council of Midway City desires to make the term limits of all Midway City advisory boards, commissions, and committees, uniform, in order to simplify and aid such bodies in their duties; and

**WHEREAS**, the City Council now desires to expand Title 2 and Title 12 of the Midway City Municipal Code to accomplish these purposes.

**NOW THEREFORE**, be it ordained by the City Council of Midway City, Utah, as follows:

**Section 2.04.020**, regarding the Planning Commission shall be amended to read as follows:

- A. Regular Members. The terms of regular members shall be ~~three~~ four years. Two consecutive ~~three-year~~ four-year terms shall be the limit for regular membership. Partial terms shall not be considered in determining whether a person has served two consecutive terms.

**Section 2.05.010**, regarding the Board of Adjustment shall be amended to read as follows:

- B. The term of office for members of the Board of Adjustment shall be ~~five~~ four years. Two consecutive four-year terms shall be the limit for regular membership.

**Section 2.08.010**, regarding the Community Development and Renewal Agency, shall be amended to read as follows:

- C. Governing Board. The governing board of the Agency shall be known as the Board of Directors of the Community Development and Renewal Agency of Midway City. The Board of Directors shall be composed of six members, consisting of the members of the Midway City Council, including the Mayor. The Board Members shall serve as members of the Governing Board for a term of four years or until his/her death

incapacity, resignation or removal from such office or, if applicable, until such officer shall cease to be a member of the City Council. Two consecutive four-year terms shall be the limit for regular membership. Each member shall have one vote except the Mayor, who shall vote only in the case of a tie. At the meetings of the Agency, any Board member may submit such recommendations and information as they may consider proper concerning the business, affairs and policies of the Agency.

**Section 2.10.050**, regarding the Municipal Building Authority, shall be amended to read as follows:

B. Number, Tenure, and Qualifications. The number of Board Members shall be six and shall consist of the members of the City Council and Mayor. Any change in the composition of the membership of the City Council shall automatically and without any action required hereunder operate to change the composition of the membership of the Governing Board. The Board Members shall serve as members of the Governing Board for a term of four years or until his/her death incapacity, resignation or removal from such office or, if applicable, until such officer shall cease to be a member of the City Council. Two consecutive four-year terms shall be the limit for regular membership. Whenever a member of the Governing Board shall cease to be a member of the City Council, his/her successor shall, upon his/her election and qualification for office, thereupon becomes a member of the Governing Board. To the extent permitted by law, members of the Governing Board may be removed and replaced by the City Council at any time in its discretion.

**Section 12.13.020**, regarding the Building Code Board of Appeals, shall be amended to read as follows:

The Board shall consist of three (3) persons appointed by the Mayor with the advice and consent of the City Council. Board members shall have experience and training in matters of building construction and shall not be employees of Midway City. Board members shall serve for four-year terms, and two consecutive four-year terms shall be the limit for regular membership. ~~A board member shall serve at the pleasure of the Mayor and the City Council and shall hold office until the member resigns or the member's replacement is appointed.~~ The Midway City Building Official shall be an additional ex officio member of the Board, but shall have no vote on any matter before the Board.

This ordinance shall take effect upon publication as required by law.
